I hereby apply for REALTOR® membership in the above-named Board. In the event of my acceptance, I agree to abide by the Code of Ethics of the National Association of REALTORS® which includes the duty to arbitrate, and the Constitution, Bylaws and Rule & Regulations. I understand membership brings certain privileges and obligations that require compliance. Membership is final only upon the approval of the Board of Directors. I understand that I will be required to complete periodic Code of Ethics training, as specified in the Association's bylaws, as a continued condition of membership. I irrevocably waive all claims against the Board or any of its officers, directors or members, for any act in connection with the business of the Board, and particularly as to its or their acts in accepting, or failure to accept, advancing, suspending, expelling, or otherwise disciplining me as an applicant or member. Upon the expiration of said membership, for any cause, I will discontinue to use the term REALTOR®, in reference to myself. **NOTE: Applicant acknowledges that if accepted as a member, and he/she subsequently resigns from the Board, or otherwise causes membership to terminate with an ethics complaint pending, the Board of Directors may condition renewal of membership upon applicant's certification that he/she will submit to the pending ethics proceeding and will abide by the decision of the hearing panel. If applicant resigns or otherwise causes membership to terminate, the duty to submit to arbitration continues in effect even after membership lapses or is terminated, provided the dispute arose while the applicant was a REALTOR®.**

I acknowledge I will be invoiced an application fee, (Brokers \$500.00, Agents \$250.00) in addition to the membership dues applicable to the month in which I submit application, or was sponsored in TREC. It is understood that this application fee and membership dues include membership in the Texas Association of REALTORS® (TR) and the National Association of REALTORS® (NAR). I understand I will be subject to annual membership dues, as set forth by Waco Association of REALTORS® (WAOR), TR and NAR. I understand that WAOR MLS fees are billed monthly to the broker/DR, (**\$50.00 monthly/Broker and \$38.00 monthly/Agent, plus tax**) and if payment is not received when due, all monthly MLS access will be suspended/terminated for that broker and all agents/members under said broker until payment is received. Broker will be invoiced for a \$250.00 reinstatement fee. Unpaid MLS fees and reinstatement fee must be satisfied to be reactivated. **NOTE: Payments to WAOR are not deductible as charitable donations. Such payments might, however, be deductible as an ordinary and necessary business expense. No refunds shall be granted. WAOR will accept checks, money orders, cashier's checks, debit or credit cards for payment. Returned checks are subject to a \$25.00 fee. If you have three returned checks within a calendar year, you will be required to pay by cashiers check, debit or credit card for the remainder of the year.**

They will then each pay the application fee and membership dues, attend the new member orientation and complete the Code of Ethics Training, or you must return their license to TREC. Otherwise, **You** will be assessed a non-member salesperson fee of \$267.00. This meets NAR Broker's dues obligations ONLY, and those agents will not receive any benefit/services (including MLS services) or hold REALTOR® membership status.
